What are the taxes in Angola?

Taxes include: industrial tax; personal income tax; stamp duty tax; investment income tax and property tax. Penalties - Angolan General Tax Code provides for a general penalty of 35% of the tax due, with a minimum of 5.000,00 Kwanza. Additionally, each tax code provides for specific penalties.

The tax system in Angola incorporates a personal income tax that is imposed on the income earned by individuals.

What is the tax rate for Foreign Service Providers in Angola?

Withholding. As per August 2020, foreign service providers will be subject to a final 15% withholding tax rate on services paid by Angolan clients. Additionally, there are specific taxes over certain categories of income, such as Property Tax (rents) and Investment Income Tax - "IIT" (capital gains).
