How does a solar PPA work?

With a Solar Power Purchase Agreement (PPA), your solar bills are based on the actual electricity generated by your solar system, so your solar bill can vary month to month. Once you have installed a system, you'll use the power that is generated. In a particularly sunny month when your system generates more power than you use, the excess power is typically credited to your account for future use.

What if I don't have the right roof for solar panels?

For those who don't have a roof suitable for solar panels or simply don't want solar panels on their property, there are options to subscribe to renewable energy projects, like community solar farms, to receive virtual net metering credits.
