Does wind energy rely on government subsidies?

All forms of energy production - whether fossil fuel or renewable - receive some level of support from federal and state governments to encourage investment. &#187; Fossil fuels have received many times more in incentives than renewables.

Does the federal government support wind power?

On top of that, the federal government has provided substantial financial support to these industries. The U.S. Energy Information Administration (EIA) reported that federal subsidies for wind power increased tenfold between fiscal years 2007 and 2010.

How much do wind and renewables get subsidized?

The wind subsidies were also about double the subsidies for natural gas and petroleum liquids and about 6.5 times greater than nuclear subsidies. Renewables received 46 percent of overall power subsidies, despite constituting a very small portion of overall power generation. This isn't subsidies per kilowatt hour of generation.

How much money does the government spend on wind power?

Despite this, lawmakers have continually tried throwing money at the problem. From 2016 to 2022, the federal government spent approximately \$18.7 billion on subsidies for wind power alone. This is a massive amount of money. It's even more considerable given that wind's intermittency heavily limits its benefit to reliability.
