How does a PUC approve a project?

It is important to note that the PUC approves both the utilities' request for proposals (RFP), the guiding document for project selection, as well as the individual project PPAs. Projects that do not go through formal competitive bids generally start the process at step four.

What is a power purchase agreement (PPA)?

Selected bidders must sign a Power Purchase Agreement (PPA) that is reviewed in another public process prior to approval.
