How do I identify a lithium battery hazardous goods container?

Except for vehicles driven by lithium batteries (pure electric or hybrid), containers containing lithium battery hazardous goods must have Class 9 hazardous goods labels and UN number markings affixed to each side and each end of the container (for lithium-ion battery energy storage systems, on two opposite sides).

How many lithium ion batteries can a shipper consign?

A shipper is not permitted to consign more than two packages of lithium or sodium ion batteries contained in equipment under Section II of PI 967, PI 970 and PI 978 where there are no more than 4 cells or 2 batteries in the package without the application of the battery mark on the package.

What is a state of charge (SOC) for lithium ion cells & batteries?

All lithium ion cells and batteries (UN 3480) and sodium ion cells and batteries (UN 3551) must be shipped at a state of charge (SoC) not exceeding 30% of their rated capacity.
